## Secretary of State—Augmentation for Department of Justice Legal Services

Pursuant to Provision 5 of Item 0890-001-0001, 2023 Budget Act, the following report is respectfully submitted.

On June 17, 2024, the Department of Finance notified the Joint Legislative Budget Committee (JLBC) that the Secretary of State (SOS) requested to augment expenditure authority by \$110,000 General Fund in fiscal year 2023-24 to cover costs of legal services provided by the Department of Justice (DOJ). Subsequently, on July 19, 2024, SOS notified Finance that DOJ submitted an additional invoice for \$138,000 for legal services provided in 2023-24, resulting in the need to augment SOS' budget by a total of \$248,000 General Fund. Provision 5 of Item 0890-001-0001 authorizes Finance to augment this item by the amount necessary to cover costs for DOJ legal services no sooner than 30 days following the transmittal of the approval to the JLBC. In addition, the SOS requested a waiver of the 30-day review period.

Finance concurs with this request and will augment SOS' budget upon JLBC approval of the requested waiver of the 30-day review period. If you have any questions or need additional information regarding this matter, please call Emma Jungwirth, Assistant Program Budget Manager, at (916)445-8913.

## **Request for Augmentation for Department of Justice Legal Services**

I am writing to formally request, pursuant to Provision 5, Item 0890-001-0001, Chapter 12, Statutes of 2023 (SB 101), an augmentation of \$247,833 General Fund for Department of Justice (DOJ) Legal Services for fiscal year 2023-24. In addition, due to the urgent timeline for payment, we kindly request a waiver of the 30-day review period.

In early April, we received an estimate from the DOJ that included legal services costs projected through June 2024. Based on that data, we determined the 2023-24 appropriation would be insufficient to cover the anticipated expenses. Consequently, we submitted a formal request for augmentation to the Department of Finance. On June 17, 2024, Finance transmitted the request to the Joint Legislative Budget Committee.

On June 20, 2024, the DOJ submitted invoicing for May 2024, which exceeded the sum of our remaining Secretary of State appropriation and the anticipated augmentation. In consultation with the DOJ, we have determined the outstanding amount to be invoiced for 2023-24. Regrettably, our current appropriation is insufficient to cover the entirety of the legal services cost.
