## Section 11.96—Coronavirus State Fiscal Recovery Fund—Final Revised Allocation Plan

Pursuant to Control Section 11.96 of the 2024 Budget Act, this revised Coronavirus State Fiscal Recovery Fund of 2021 (SFRF) allocation plan, based on the most updated information, is respectfully submitted. A final allocation plan will be provided prior to the December 31, 2024, SFRF obligation deadline if amendments are required for the existing allocation plan.

# Transfer Unspent SFRF from Local Assistance to State Operations for the Accelerate Affordable Housing Production (Accelerator) Project

Control Section 11.96, Subdivision (c), authorizes the Department of Finance to transfer amounts between state operations and local assistance to support the implementation of the same programmatic purpose. The Department of Housing and Community Development (HCD) received \$1.7 billion of SFRF for Accelerator which provides development capital for shovel-ready affordable housing projects stalled due to insufficient supply of tax credits and bonds. Finance requests to transfer \$4 million from local assistance to state operations to support ongoing costs in administering the project. In addition to Accelerator's initial appropriation of \$9 million for administrative costs, this \$4 million transfer falls within the five percent eligible to be transferred to state operations pursuant to the Budget Act of 2021.

### Transfer Budgetary Authority and Expenditures to General Fund for Specified SFRF Projects

Subdivision (j), authorizes the Director of Finance to transfer SFRF to General Fund up to the full amount of the revenue loss calculation. As part of its continual monitoring of SFRF projects and to ensure SFRF is fully obligated by December 31, 2024, Finance requests that budgetary authority and associated expenditures for the following SFRF projects be transferred from SFRF to General Fund, pursuant to Subdivision (k). This proposed \$5.9 million General Fund amount will be offset by an equivalent amount of available revenue loss under the SFRF revenue loss calculation. Therefore, there will be no net impact to the General Fund and no net change in the funding levels for any of the programs proposed for this transfer.

- HCD's Accelerator project: \$4 million in addition to \$1,713,210,759 specified in previous Joint Legislative Budget Committee notices.
- Judicial Council's Legal Services for Eviction Prevention and Housing Stability project: \$1,864,730.

#### **Revert SFRF Project Savings**

Further, Subdivision (i) authorizes the Director of Finance to initiate the reversion of unspent funds from an appropriation for a specific programmatic purpose from the SFRF.

The California Community Colleges Chancellor's Office (Chancellor's Office) has concluded its Emergency Financial Aid for Community College Students project and has identified remaining savings through its apportionment process. To maximize the use of SFRF, Finance intends to revert savings of \$5,133,819 from Item 6870-162-8506.

Finance will continue to work with all agencies to identify and revert any additional SFRF project savings prior to the December 31, 2024 obligation deadline, which will be reflected in the final allocation plan.

#### **Request 30-Day Period Waiver**

Finance also requests, pursuant to Subdivision (m), a waiver of the 30-day notification period to process these adjustments prior to the December 31, 2024 obligation deadline.

Finance will process these requests in the following order: (1) transfer budgetary authority from local assistance to state operations for Accelerator, (2) transfer SFRF budgetary authority to General Fund in the amount specified above, along with any expenditures, (3) revert the SFRF project cost savings, and (4) transfer an amount equivalent to (2) and (3) from available revenue loss under the SFRF revenue loss calculation, pursuant to Subdivision (j).
