Notification of Receipt and Approval of an Unanticipated Cost Funding Request from the Secretary of State

Pursuant to Provisions 3 and 6 of Item 9840, 2024 Budget Act, we are transmitting the attached unanticipated cost funding request from the Secretary of State, which was received on March 20, 2025. At the time of the 15-day notification period, the Department of Finance was evaluating the proposal and this letter serves as the 15-day and 30-day notification.

The Secretary of State is responsible for printing and mailing Voter Registration Cards, Voter Notification Cards, the Voter Information Guide, and Text of Proposed Laws for each statewide election. These costs as well as parallel monitoring, printing and mailing voter registration cards, and election night reporting are funded through the Secretary of State's Special Items of Expense appropriation. The 2024 Budget Act, pursuant to Provision 2 of Item 0890-001-0001, authorizes \$10,615,000 for this purpose. The Secretary of State projects costs of \$19,202,000 in the current fiscal year, resulting in a shortfall of \$8,587,000. This shortfall is driven primarily by printing and mailing costs of the Voter Information Guide for the November 2024 general election. Costs associated with the Voter Information Guide have consistently increased in recent years due to paper shortages, and increased postage and mailing costs.

The Governor's Budget proposes an ongoing augmentation of \$4.5 million beginning in 2025-26 for this purpose. Finance will continue to evaluate this amount to better align the budget with actual costs in recent years.

Finance has completed the review and concurs with the request. Funding for this unanticipated cost request will be provided from Item 9840-001-0001, Augmentation for Contingencies or Emergencies, in the amount of \$8,587,000.

Finance requests an expedited review of the submission and a waiver of the 30-day waiting requirement since the costs have already been incurred for this purpose.
