Pursuant to Section 1, of Chapter 189, Statutes of 2023, which amends Section 19.56 of the Budget Act of 2022, and Sections 19.561 through Section 19.569 of Chapter 189, Statutes of 2023, the Department of Finance respectfully submits Attachments 1 and 2, which reflect changes to the local fiscal agents in those sections. Under Provision 6 of each of these sections, the allocating authority may, in consultation with Finance, use an alternative local fiscal agent. Finance worked in close consultation with legislative staff to coordinate these changes.
