Notification Pursuant to Section 77 of AB 106 (Ch. 9, Stats. 2024)

Pursuant to Section 77 of AB 106, Chapter 9, Statutes of 2024, the following information is respectfully submitted.

Section 77 of AB 106 requires the following of the Department of Finance:

"No later than seven days following enactment of the act adding this section, the Director of Finance shall provide to the Joint Legislative Budget Committee a list of adjustments to commitments related to past budget agreements that will no longer be included in baseline budget forecasts and no longer fulfilled under spring 2024 budget agreements that help address significant deficits projected in the 2024–25 fiscal year and future fiscal years."

The attachment included in this notification is responsive to the requirement noted above. The Early Action agreement results in total solutions related to previous commitments of \$17.3 billion. Items listed in the attachment represent early legislative agreement to these solutions.

In addition to requesting that the Director of Finance provide this list of adjustments, Section 77 states legislative intent that 2024 May budget forecasts reflect transfers from the Budget Stabilization Account and the Public School System Stabilization Account to the General Fund proposed in the 2024-25 Governor's Budget, as updated in the 2024-25 May Revision, pursuant to Sections 20 and 21 of Article XVI of the California Constitution, which are expected to be made in the Budget Act of 2024 to help address the significant deficit projected in the 2024-25 fiscal year.
