### **Section 28.00—Department of Social Services**

Pursuant to the provisions of Section 28.00, 2020 Budget Act, the following report is respectfully submitted.

The Department of Finance has received the attached Section 28.00 application from the Department of Social Services (DSS) for the purpose of increasing federal expenditure authority in Item 5180-151-0890 by \$64,602,000, for Program 4275019-Children & Adult Services and Licensing. The increased expenditure authority is needed for the following reasons:

**Adult Protective Services Programs—**\$9,477,000 for the purpose of expending federal funds recently awarded by the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 for Adult Protective Services Programs. The increase in Federal Fund authority in fiscal year 2020-21 is requested to supplement existing county-run Adult Protective Services Programs. DSS received official notification of the availability of additional, unanticipated funds on April 1, 2021 and notified Finance within 45 days of this date.

**John. H. Chafee Foster Care Independence (Chafee) Program—**\$55,125,000 for an increased funding award for the John. H. Chafee Foster Care Independence Program included in the federal Consolidated Appropriations Act of 2021. DSS received official notification of the availability of additional, unanticipated funds Chafee program funding on March 9, 2021 and notified Finance within 45 days of this date.

These requests meet the following criteria, as required in subdivision (b) of Section 28.00:

- The funds will be expended to assist with Adult Protective Services and Chafee grants for foster youth, which is consistent with state law.

- The funds are made available to the state under conditions permitting their use only for the specified purposes, and the additional expenditure proposed would apply to those specified purposes.
- Acceptance of the additional funding does not impose on the state any requirement to commit or expend new state funds for any program or purpose.

Finance concurs with the necessity of these changes to the approved budget as this funding will provide resources needed to support Adult Protective Services Programs and foster youth and non-minor dependents during the COVID-19 pandemic. Given the health and safety concerns of the COVID-19 pandemic, DSS respectfully requests the Committee's waive the 30-day waiting period requirement for an expedited review of this notification.

**PART A: For what purpose will the funds be expended?**

CDSS will invest the additional funds provided by the Federal Consolidated Appropriations Act of 2021 to supplement existing Title IV-B programs. Specifically, the Department will utilize these funds by providing a one-time direct support for current and former foster youth age 18-26, consistent with governing rules outlined in ACYF-CB-PI-21-04 for Chafee funding. Additionally, funding provided for Educational Training Vouchers (ETV) will be used to exhaust the current ETV waitlist.

**PART B: Explain the need to expend the funds in the current fiscal year, including the consequence of waiting until budget year to expend the funds:**

Current and former foster youth are still enduring the lingering effects of the COVID - 19 pandemic. If delayed, foster youth will continue to face additional hardships, including those magnified by the COVID - 19 pandemic. Upon approval of this request CDSS will provide support as quickly as possible and meet the goals outlined in the Supporting Foster Youth and Families through the Pandemic Act.

**DESCRIPTION:**

The federal Consolidated Appropriations Act of 2021 (P.L. 116-260) was enacted December 27, 2020, and provides \$400.0 million in additional funding nationally for the John H. Chafee Foster Care Independence Program (Chafee) with a minimum required allocation to the Chafee Education and Training Voucher (ETV) program of \$50.0 million. California received a total of \$47.2 million of this additional funding. Of this funding, approximately \$6.0 million is specific to the ETV program, and approximately \$3.3 million in additional funding will be dedicated to the ETV to exhaust the current ETV waitlist and bring award recipients up to the maximum \$5,000 funding level. A total of approximately \$4.0 million will be set aside to be dedicated to the Foster Youth to Independence program which will allow for Public Housing Authorities to request housing choice vouchers to serve youth under the age of 25 with a history of child welfare involvement for up to 36 months. The remaining funding will be dedicated to providing direct financial support for current and former foster youth age 18 - 26 who are or were eligible for Extended Foster Care (including approximately \$2.6 million for outreach and \$100,000 for administration of the support). Initial financial support will be provided as soon as possible and a second round of financial assistance may be provided in the Budget Year if funds amounting to more than an additional \$100 per young adult are remaining. A total amount of remaining funding that is less than \$100 per young adult would be additionally dedicated to the FYI program.





In accordance with Section 477(d)(2) of the Act, the Education and Training Voucher program funds may be used to supplement not supplant any other funds which are available for the same general purposes in the State or tribe.

Financial Reporting

The expenditure reporting form used is the SF-425 Federal Financial Report. This report is submitted annually and must be submitted no later than December 30 - 90 days following the end of each Federal Fiscal year. SF-425 reports must be submitted each grant year funds are available: four interim reports covering year one thru four of the project periods and a final report (cumulative) covering the entire project period. These annual reports must be submitted electronically through the HHS Payment Management System (PMS).

Funding (project) period and obligation period. In accordance with Section 477(d)(3) of the Act, this program has a 2-year project/obligation period starting the first day of the Federal Fiscal Year, October 1, for which funds were awarded and ending the last day of the following Federal Fiscal Year, September 30. Any Federal funds not obligated by the end of the respective obligation period will be recouped by this Department. Such funds shall then be subject to redistribution to other program grantees in accordance with Section 477(d)(5) of the Act.

Liquidation period. In accordance with 45 CFR § 75.309(b), all obligated Federal funds awarded under this grant must be liquidated no later than 90 days after the end of the funding/obligation period. Any Federal funds not liquidated by December 30 will be recouped by this Department.

These annual reports must be submitted for approval to the appropriate ACF Regional Program Office.
