Pursuant to the provisions of Section 28.00, 2022 Budget Act, the following report is respectfully submitted.

The Department of Finance has received the attached Section 28.00 application from the California Arts Council for the purpose of increasing its Federal Trust Fund authority, Item 8260-101-0890, by \$300,000 to receive federal funds to support arts programs and activities associated with carrying out the Arts Council's National Endowment for the Arts-approved strategic plan. In total, the Arts Council will receive \$1,397,000 from the National Endowment for the Arts and needs additional authority to be able to accept the entire award.

The California Arts Council received official notification of the availability of additional, unanticipated funds on July 18, 2022, and notified Finance within 45 days of this date. The delay between receiving the notification and this letter is because the Arts Council was working through the grant application and approval process and additional time was needed to determine which item needed to be augmented to accept the funds.

This request meets the following criteria, as required in subdivision (b) of Section 28.00:

- The funds will be expended for purposes none other than what is outlined within the grant contract, which is consistent with state law.
- The funds are made available to the state under conditions permitting their use only for the specified purpose, and the additional expenditure proposed would apply to this specified funding purpose.
- Acceptance of the additional funding does not impose on the state any requirement to commit or expend new state funds for any program or purpose.
- The need exists to expend the additional funding during the current fiscal year to prevent the federal funds from being reverted on October 31, 2023.

Finance concurs with the necessity of this change to the approved budget and will be approving the Section 28.00 application not sooner than 30 days from the above date.
