## Secretary of State—Augmentation for Department of Justice Legal Services

Pursuant to Provision 6 of Item 0890-001-0001, 2022 Budget Act, the following report is respectfully submitted.

The Department of Finance has received a request from the Secretary of State (SOS) to augment expenditure authority to cover costs for legal services provided by the Department of Justice (DOJ). Provision 6 of Item 0890-001-0001 authorizes Finance to augment this item by the amount necessary to cover costs for DOJ legal services. On May 18, 2023, DOJ notified SOS of a correction to the billing for legal services for costs incurred from July 2022 through April 2023, resulting in total costs of \$1.9 million for that period. The SOS is projected to accrue additional costs of \$389,000 by June 30, 2023, bringing total costs for legal services for 2022-23 to \$2.3 million. The current SOS appropriation for DOJ legal services is \$852,000, therefore an additional \$1,481,000 is needed to cover these costs. In addition, due to the constrained timeline for payment, SOS requests a waiver of the 30-day review period.

## Request for Augmentation for Department of Justice Legal Services

Pursuant to Provision 6, Item 0890-001-0001, Chapter 249, Statutes of 2022 (AB 179), the Secretary of State (SOS) requests an augmentation of \$1,480,452 General Fund in 2022-23 for Department of Justice Legal Services (DOJ). In addition, due to the constrained timeline for payment, the SOS requests a waiver of the 30-day review period.

The SOS received notification from the DOJ, on May 18, 2023, of a correction to the billing for legal services costs already incurred from July 2022 through April 2023. The SOS current appropriation is insufficient to cover the additional cost, and absent a budget augmentation, it may be necessary for the DOJ to cease litigation work on behalf of the SOS until July 1, 2023.

This letter is a formal notification that the Secretary of State is anticipated to exceed its fiscal year (FY) 2022-23 budget for the legal services provided by the Office of the Attorney General (OAG)-Department of Justice (DOJ), as outlined in Item 0890-001-0001 (4) of the Budget Act of 2022.

Legal services costs already incurred from July 2022 through April 2023 total approximately \$1,943,709.82. Should current hourly workload trends continue, the Secretary of State is projected to accrue additional costs totaling \$388,741.96 by June 30, 2023. As the Secretary of State's budget only allows for \$852,000 in costs for legal services provided by the Department of Justice, a shortfall of approximately -\$1,480,451.78 is anticipated by year end.

DOJ acknowledges that the Secretary of State may require a budget augmentation pursuant to Provision 6 of Item 0890-001-0001 of the Budget Act of 2022 in order to secure the necessary funding for continued legal services. Absent a budget augmentation as described above, it may

be necessary for the OAG to cease work on the Secretary of State's cases until July 1, 2023, thereby slowing the pace of prosecution of the program's disciplinary actions.
