## Memorandum of Understanding Addendum

Pursuant to Provision 7 of Item 9800-001-0001 of the 2020 Budget Act, this notification is to inform you of a recent addendum reached with the California Correctional Peace Officers Association (State Bargaining Unit 6).

## Side Letter #21-027—California Correctional Peace Officers Association (State Bargaining Unit 6)

Side Letter #21-019, reached on June 6, 2021 with the California Correctional Peace Officers Association (State Bargaining Unit 6), stated that various pay items were to be effective the first day of the pay period following ratification with the intent of that date being July 1, 2021. Since the Legislature is taking action to ratify this side letter on July 1, 2021, the first day of the next pay period would be August 1, 2021. To prevent the delay in implementation and meet the intent of Side Letter #21-019, a new side letter was reached on June 30, 2021 with State Bargaining Unit 6 to clarify the effective date of the various pay items is July 1, 2021.
