RE: Department of Parks and Recreation, Operating Agreement with Marconi Conference Center Operating Corporation for Operation of Marconi Conference Center State Historic Park (SHP)

The following notification is respectfully submitted in accordance with the requirements of Public Resources Code §5080.40:

- (a) No operating lease or agreement shall be entered into, or amended, pursuant to this article unless at least 30 days' written notice and a copy of the proposed operating lease or agreement, or amendment, has been provided by the director to the Joint Legislative Budget Committee.
- (b) The director shall include with the proposed lease or agreement or amendment sufficient documentation to enable the Joint Legislative Budget Committee to evaluate fully the estimated operating costs and revenues and all terms upon which the lease or agreement or amendment is proposed to be entered into. Specifically, the documentation shall identify both of the following:
 - (1) Any anticipated costs to the state for operation or development under the lease or agreement or amendment and the anticipated state share of total operation and development costs.
 - (2) The anticipated annual revenues, net of operation costs, for the unit and the state's share of these revenues.

In accordance with the above, the Department hereby provides the Joint Legislative Budget Committee with notice of the proposed 55-year operating agreement with Marconi Conference Center Operating Corporation (MCCOC) to operate, develop, and maintain the Marconi Conference Center State Historic Park.

Consistent with these notification requirements, the Department has enclosed the proposed operating agreement and identified anticipated costs and revenues associated with this proposal.

Anticipated Costs

State may process up to six Project Evaluation Forms (PEF's) annually, up to \$100,000 per maintenance project, to the level of a Notice of Exemption. State anticipates the number of hours needed to process the PEF's to be minimal.

<u>Anticipated Annual Revenue</u>

During the 55-year term it is anticipated the average annual net revenue to the MCCOC sub-operator will be \$825,950.

There is no predetermined share of revenue to State; however, starting year five and continuing once every five years thereafter, MCCOC and State shall review the Trust Fund account balances and financial needs of the Premises. If MCCOC and State determine the Facility Maintenance and Improvement Account balances exceed the needs of the Premises, MCCOC and State may request a transfer to be paid as additional rent to MCCOC and/or State.
